#### ORDERED AND ADJUDGED

The Motion for Relief from Stay is hereby granted so that the District may 1. proceed with its state court remedies to collect special assessments which have been levied against the real property of the Debtors as described in Exhibit "A" attached hereto, together with interest, statutory penalties and attorneys' fees pursuant to FLA. STAT. §170.10, including its pending foreclosure action.

It is furthermore ordered that relief from the

Automatic Stay is granted to the extent necessary for the District to make such additional levies of special assessments as may be necessary and appropriate, from time to time, to fund the operations and maintenance budget of the District, and to take such action as may be necessary to enforce and collect such assessments, including such additional foreclosure actions as may be necessary in the event of default in the payment thereof.

2. The relief granted here permits the Creditor to seek and obtain in rem remedies against the property only and does not permit the Creditor to seek or obtain in personam relief against the Debtor.
